

1. **Sealed Bids:** Sealed bids for the construction of **Sanitary Sewer Rehabilitation for the Fitzgerald Water, Light & Bond Commission** will be received until **2:00 p.m., July 11, 2019** at the **Commission Chambers, Fitzgerald Water, Light and Bond, 103 West Central Avenue, Fitzgerald, GA** at which time and place all Bids will be publicly opened and read. No bid may be withdrawn after the closing time for receipt of bids for a period of sixty (60) days.
2. **Contractor License:** Any Contractor submitting a bid must be licensed by the State of Georgia. License numbers must be written on the face of the bid envelope. No bid will be opened unless it contains the Contractor's license number. See Instructions to Bidders for additional bidding requirements.
3. **Work To Be Done:** The work to be done shall consist of furnishing all labor, materials and equipment necessary to construct the project titled **Sanitary Sewer Rehabilitation Improvements – S. Lee Street, E. Ohoopce Street, and two (2) locations along West Central Avenue**, as shown on the construction drawings. In general, construction consists of sanitary sewer main and service lateral rehabilitation and/or replacement in accordance with project schedules. Manhole rehabilitation work is also inclusive. Major items of construction include: 8” pipe-bursted main, 8” cured-in-place pipe, 4” service pipe replacement (open-cut, reconnections and/or pipe-burst/static pull on existing laterals and ± 225 VF of manhole rehabilitation. Work also includes new sewer manholes and clean-outs in accordance with plan drawings and schedules and all other associated appurtenances necessary for a complete and operational project including asphalt and concrete pavement patches in. The goal of the work is to reduce system infiltration.
4. **Plans and Contract Documents:** Plans and Contract Documents are on file for review at the **Fitzgerald Water, Light and Bond, 200 N. Hooker Street** and at **103 West Central Avenue** and at the Dodge Plan Room in Macon. 5. **Bonds:** All bid forms must be accompanied by a Bid Bond in an amount not less than ten percent (10%) of the base bid. All bonds shall be by a surety company licensed in Georgia with an “A” minimum rating of performance and a financial strength of at least five (5) times the contract price as listed in the most current publication of “Best’s Key Rating Guide Property Liability”. The successful bidder, if awarded the Contract, will be required to furnish a Performance Bond and Payment Bond, each in the amount of one hundred percent (100%) of the Contract amount. Each bond shall be accompanied by a “Power of Attorney” authorizing the attorney-in-fact to bind the surety and certified to include the date of the bond. All bonds must appear on the Treasury Department's most current Circular 570 Listing.
